

## St Alban's Catholic Primary School History Policy 2024 - 2025

### Introduction

This policy outlines the purpose, nature and management of the history taught and learnt in our school. It has been adopted by the staff of St Alban's Catholic Primary School. This policy outlines the guiding principles by which this school will implement history through the National Curriculum and a curriculum relevant for the children in our school. It is reviewed periodically.

### Rationale for History teaching

History should be concerned with stimulating the children's interest in and understanding of the life of people and ancient civilisations from the past. We aim for the children to develop a sense of identity, and a cultural understanding based on their historical heritage. We teach children to understand how events in the past have influenced our lives today; we also teach the children to investigate these past events and, by so doing, develop the skills of enquiry, analysis, interpretation and problem solving.

### Aims for the teaching of History at St Alban's Catholic Primary School

At St Alban's Primary School our intention is to provide quality teaching and learning of history. We aim:

- To promote an interest in the past.
- To develop an understanding of events over time and in a chronological structure.
- To learn about the roles that individuals and events have played in shaping modern society.
- To develop an ability to investigate and interpret different versions of past events.
- To learn to study historical evidence and to ask and answer questions about the past.
- To develop the ability to communicate historical knowledge and understanding using a variety of techniques.
- To encourage children to understand other people, their beliefs, thoughts, values and experiences.
- To develop an awareness of the world around them.

### Attitude and skills

We also seek to encourage children to develop the following skills:

- Empathy
- Interpretation of secondary and primary sources
- Historical enquiry
- Communicating history dramatically, verbally and narratively
- Research

### The Role of the History Co-ordinator is:

- Taking the lead in the development, evaluation and amendment of schemes of work as and when necessary.
- Acting as a consultant to colleagues on resources, visits, visitors, curriculum changes, classroom teaching and learning ideas.
- Monitoring and evaluating pupils' work, pupils' views about the subject, displays and teachers' planning.
- Writing School development plan.
- Auditing resources and ordering resources when needed.
- Keeping up to date with developments in history and disseminating information to the rest of the teaching staff.
- Leading staff meetings as appropriate.
- Attending relevant in-service training and prompting others about relevant training.

### Early Years

History in the Early Years is taught under the umbrella of 'Knowledge and Understanding of the World' from the EYFS. The children are supported in developing the knowledge, skills and understanding that helps them to make sense of the world. The pupils are encouraged to talk about their families and past and present events in their lives. They are beginning to gain knowledge and understanding of the world through:

- Photographs
- Listening to stories and memories of older people
- Role play activities
- Discussing events in the past and their own personal lives
- Sequencing events to gain a sense of time in their world such as earlier, yesterday...

### Key Stage 1

The National Curriculum Programme of Study at Key Stage 1 focuses on developing children's awareness of the past, using common words and phrases relating to the passing of time. They should know where the people and events they study fit within a chronological framework and identify similarities and differences between ways of life in different periods. Children should use a wide vocabulary of everyday historical terms. They should ask and answer questions, choosing and using parts of stories and other sources to show that they know and understand key features of events.

They should understand some of the ways in which we find out about the past and identify different ways in which it is represented through the observation and experience of artefacts and sources.

In planning to ensure the progression described above through teaching about the people, events and changes outlined below, teachers are often introducing pupils to historical periods that they will study more fully at Key Stage 2. This begins in Year 2 when the children learn about the Stone Age using the Opening Worlds curriculum as taught in Key Stage 2 presently.

Pupils should be taught about:

- Changes within living memory.
- Events beyond living memory that are significant nationally or globally.
- The lives of significant individuals in the past who have contributed to national and international achievements.
- Significant historical events, people and places in their own locality.

### Key Stage 2

The National Curriculum Programme of Study at Key Stage 2 should continue to allow children to develop a chronologically secure knowledge and understanding of British, local and world history, establishing clear narratives within and across the periods they study. They should note connections, contrasts and trends over time and develop the appropriate use of historical terms. They should regularly address and sometimes devise historically valid questions about change, cause, similarity and difference, and significance. Children should construct informed responses that involve thoughtful selection and organisation of relevant historical information. They should understand how our knowledge of the past is constructed from a range of sources.

## **Recording of History**

Pupils are encouraged to record their work using a variety of methods and therefore communicate their findings to others. These may include written or verbal reports, charts, collage, models, pictures and role play activities. Examples of children's work will be retained to provide evidence of on-going history, including photographic evidence of displays, presentations, visiting speakers and historical visits.

## **Classroom management**

The history curriculum follows specific units of work which are annually reviewed to ensure current initiatives are included.

Planning for KS1 is identified on school planning Medium Term plans. It is recorded in Early Years on the Early Years' planning proformas and Years 3 – 5 presently studying our new Opening Worlds curriculum planning is through the teaching slides provided by Opening Worlds.

History is taught in alternate half terms for KS1 & Year 6, alongside geography. History is taught once a week and in Years 3 – 5 a new topic is taught each half term.

## **Cross Curricular links in History Literacy**

History contributes significantly to the teaching of English in our school by actively promoting the skills of reading, writing, speaking and listening. Some of the texts that are used in English lessons are historical in nature. Children develop oracy through discussing historical questions or presenting their findings to the rest of the class. They develop their writing ability by composing reports and letters and through using writing frames.

## **Numeracy**

History teaching contributes to the teaching of mathematics in a variety of ways. Children learn to use numbers when developing a sense of chronology through doing

activities such as time-lines and calculating time differences between different era's. Children learn to interpret information presented in graphical or diagrammatic form.

### **Computing**

We use computing in history teaching where appropriate. Children use computing in history to enhance their skills in data handling and in presenting written work, and they research information using the Internet. Each teacher ensures it is used as a teaching tool where appropriate, and provides opportunities for children to also use it.

### **Personal, Social and Health Education (PSHE)**

History contributes significantly to the teaching of personal, social, citizenship and health education. Children develop self-confidence by having opportunities to explain their views on a number of social questions such as how society should respond to poverty. They learn how to recognise and challenge stereotypes. They learn how society is made up of people from different cultures and start to develop tolerance and respect for others.

### **Assessment**

Children's progress should be monitored through observation and by using planning and learning objectives. Initial knowledge at the start of each topic is assessed in ways such as mind maps for the new Opening Worlds learning but by completing a topic cover 'What I know now' section for year groups continuing our school History curriculum..

### **Marking**

Feedback to pupils should be provided on their attainment against the objectives of history. Pupils are encouraged to improve their own learning performance through the school marking policy.

### **Monitoring and Evaluation**

History will be monitored throughout the school by the History Co-ordinator who will be responsible for gathering samples of curriculum work.

The History Co-ordinator will also monitor history books and schemes of work to ensure that the Programmes of Study are being effectively taught and match the needs and abilities of the pupils.

Lessons ideally will also be monitored to help promote quality of learning and standards of achievement in history.

## **Inclusion**

### **Equal Opportunities**

- We plan our classroom activities to challenge and involve all pupils appropriately, according to age and capability, ethnic diversity, gender and language background
- We are aware of different learning styles and the need to allow pupils to be able to work in their preferred learning styles for some of the time
- We use materials for teaching which avoid stereo-typing, and bias, towards race, gender, role or disability
- We deal with such issues clearly and sensitively when they arise

### **Scaffolding**

At our school we teach history to all children, whatever their ability. History forms part of the school curriculum policy to provide a broad and balanced education to all children. Through our history teaching we provide learning opportunities that enable all pupils to make progress. We do this by setting suitable learning challenges and responding to each child's different needs. Assessment against the National Curriculum allows us to consider each child's attainment and progress against expected levels. We use a range of strategies to support pupils. A few of these, particularly relevant to History are:

- The use of appropriate vocabulary at varying levels of difficulty during lessons
- Modified text passages as expected in other curriculum areas
- Different levels of written or oral questions for pupils investigating photographic or other visual material
- Careful use of support for pupils with English as an additional language

### **For our children at 'greater depth' level, we will expect:**

- Teachers provide teaching and learning experiences that encourage pupils to think creatively, explore and develop ideas, and try different approaches. Pupils should be encouraged to set their own questions, offer ideas, suggest solutions or explanations, and reflect on what they have heard, seen or done in order to clarify their thoughts.
- Greater independence in working, e.g. a pupil to be able to carry out their own simple historical enquiry

- Avoid giving gifted pupils additional writing tasks and encourage them instead to communicate their understanding in a variety of ways, giving them responsibility for choosing and evaluating the most appropriate method.
- Provide opportunities within history for pupils to develop their skills in other areas, such as intrapersonal skills (for example, opportunities to use initiative), and interpersonal skills (for example, leadership and group membership). These opportunities also relate to the key skills of working with others and improving one's own learning and performance.

### **Resources**

Artefacts and resources are also viewed when external visitors, through workshops, in school. Teachers are urged to include a trip to external sites within the school year to access high quality resources. These resources enrich and stimulate children's historical enquiry. Resources held include artefacts, primary and secondary source documents, photographs, and recommended history sites on the internet such as the British Museum in London.
